Annexure-II

Terms and Conditions for appointment of Doctor:

1. An honorarium will be Rs. 60,000/- pm for Full Time and Rs. 30,000/- pm for Part time (4 hours per day)
2. The Doctor should be ready to attend to any emergency case.
3. He will be responsible for attending OPD patients, emergencies, vaccination clinic, and other duties and responsibilities entrusted.
4. The post is purely temporary and on a contractual basis. The position is initially for 11 months (only one term).
5. The appointment can be terminated at any time on either side by giving one month's notice without assigning any reason.
6. The appointee shall not be entitled to any benefits like Provident Fund, Pension, Gratuity, Medical Attendance rules, Seniority, Promotion, etc., or any other benefits available to Government servants appointed regularly
7. The appointee will not be granted any claim or right for regular appointment to any post in SGGSI&T Nanded.
8. A medical fitness certificate from the competent medical authority must be produced at the time of appointment.
9. Candidate will submit an undertaking that they will not make any claim of permanency or regularization, or a claim for being a regular employee, consequent to this engagement by submitting an undertaking and an Affidavit on Rs.100/- stamp paper duly notarized at the time of joining.
